**ORDERS FOR AN EXTENSION OF THE TIME PERIODS REQUIRED TO BE  
GIVEN UNDER S 239AT OF THE COMPANIES ACT 1993**

1. The without notice application made by **WILLIAM GUY BLACK** and **CONOR JOHN MCELHINNEY** on 22 June 2017 was determined by the Honourable *Justice Duffy* on the *23<sup>rd</sup>* day of June 2017.
2. The determination was made without a hearing.
3. The following orders were made:
  - (a) the applicants are granted leave to commence this proceeding without notice;
  - (b) the convening period as defined in s 239AT(2) of the Companies Act 1993 ("**Act**") be extended by a further 62 days to an end date of 31 August 2017, under s 239AT(3) of the Act;
  - (c) the administrators may convene a watershed meeting in respect of any of the Companies at any time within the period for which an extension has been granted;
  - (d) within seven days of the date of these Orders, the applicants:
    - (i) advertise the Orders once in *The New Zealand Herald*; and
    - (ii) post a copy of the orders on McGrathNicol's website.
  - (e) costs of this application are an expense incurred by the applicants in carrying out their duties as administrators of the Group, and are to be paid out of the assets of the Group; and
  - (f) leave to apply is granted to any person who can demonstrate a sufficient interest to modify or discharge either the above orders upon appropriate notice being given to the applicants.
