6 By no later than 3 working days before the trial date, the parties and any person or entity granted leave to be heard on the application pursuant to order 1 above, to provide to the Associate to the Trial Judge a Court Book consisting of all evidence, any objections thereto (limited to those that are essential having regard in particular to s 190(3) of the Evidence Act 1995) and copies of their outlines of submissions.

7 Liberty to apply on 2 business days' notice and specifying the relief sought.

8 Note that the liquidators will use their best efforts to notify the creditors of the companies of the tentative hearing dates specified above in the manner in which notice of this application was given previously.
