Conor McElhinney and Andrew Grenfell (**Liquidators**) were appointed jointly and severally as liquidators of the Company on 7 February 2020 by a resolution of the Company's creditors at the Watershed Meeting.

### 4. Report on conduct of the liquidation

Kumfs Group Limited is a non-operating holding company for the three trading entities within the Ziera group, being Ziera Shoes NZ Limited (In Liquidation), Ziera Retail NZ Limited (In Liquidation) and Ziera Retail Pty Limited (In Liquidation), and Kumfs Brand Limited which held the intellectual property relating to the Kumfs and Ziera brands. Accordingly, the tasks required to be undertaken by the Liquidators during this reporting period were limited to:

- a) Recovery of assets owing to related entities within the group.
- b) Meeting statutory obligations with regards to tax and reporting.

### 5. Proposals for completing the liquidation

The Company operated as part of a wider group with Ziera Shoes NZ Limited (In Liquidation), Ziera Retail NZ Limited (In Liquidation) and Ziera Retail Pty Limited (In Liquidation) being funded via intercompany advances. The Liquidators are in the process of recovering a tax refund within the group. There will be one further distribution to creditors before the liquidation is finalised in November 2021.

### 6. Liquidators' Declaration of Independence, Relevant Relationships and Indemnities (**Declaration**)

The Liquidators provided a Declaration in the Watershed Report dated 29 January 2020 previously provided to creditors. There have been no changes since that report.

### 7. Liquidators' remuneration

The Liquidators' remuneration is charged on an hourly basis at their standard hourly rates. These rates, the qualifications and experience generally of staff at each level, and how we charge disbursements, was set out in our first report dated 14 February 2020. There has been an annual increase in the Liquidators' hourly rates effective 1 April 2020, and 1 April 2021.

There has been no Liquidators' remuneration paid for the period 7 February 2021 to 6 August 2021 by this entity.

### 8. Estimated date of completion of liquidation

The Liquidators estimate the date of completion for the liquidation to be 30 November 2021. However, finalising the liquidation is dependent on third parties that are outside the Liquidators' control.
