1. Appointment

William Black and Conor McElhinney of McGrathNicol New Zealand were appointed jointly and severally as Administrators of the Company on 1 June 2017 by a resolution of the Company's Directors, pursuant to Part 15A of the Companies Act 1993 (**Companies Act**).

The Company is part of a group of seven companies which were all placed into Administration on 1 June 2017 (the **Group**).

At the Watershed Meeting held on 1 September 2017 the creditors resolved that the Company be placed into liquidation. William Black and Conor McElhinney (**Liquidators**) were appointed joint and several liquidators in accordance with section 241(2)(d) of the Companies Act. On 13 November 2019, William Black retired as Liquidator and Kare Johnstone was appointed.

The Liquidators are Licensed Insolvency Practitioners pursuant to the Insolvency Practitioners Regulation Act 2019. Liquidators of insolvent companies are required to be licensed insolvency practitioners. You may obtain more information regarding the regulation of insolvency practitioners from the Registrar of Companies.

The Liquidators are members of the Restructuring Insolvency and Turnaround Association of New Zealand Inc (**RITANZ**) and accordingly act in compliance with the RITANZ Code of Professional Conduct, a copy of which can be located on RITANZ's website (www.ritanz.org.nz).

- b) That the Company is a party to legal proceedings; or
- c) That the Company is in receivership; or
- d) That the person is a creditor, or a shareholder, or a person who has an undischarged claim against the Company; or
- e) That the person believes that there exists, and intends to pursue, a right of action on behalf of the Company under part 9 of the Companies Act; or
- f) That, for any other reason, it would not be just and equitable to remove the Company from the Companies Register.
